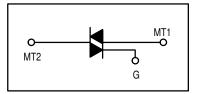

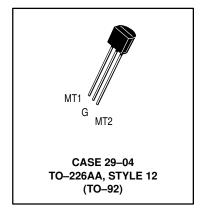

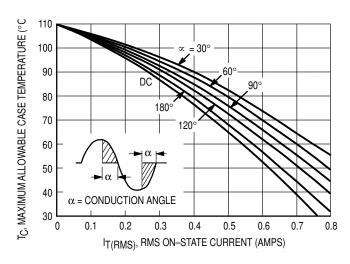


Figure 1. RMS Current Derating

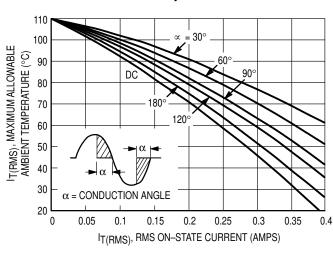


Figure 2. RMS Current Derating

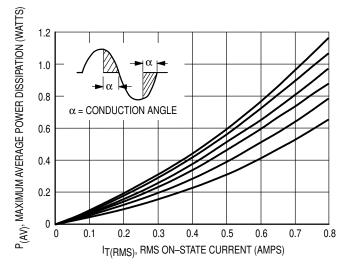


Figure 3. Power Dissipation

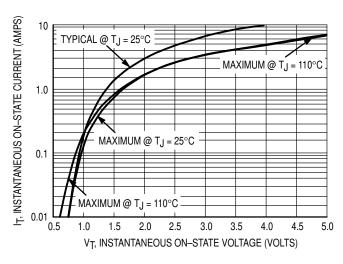


Figure 4. On-State Characteristics

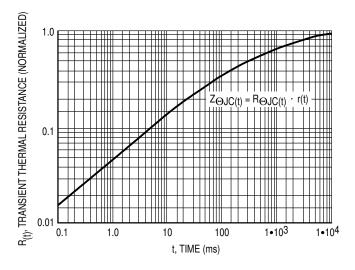


Figure 5. Transient Thermal Response

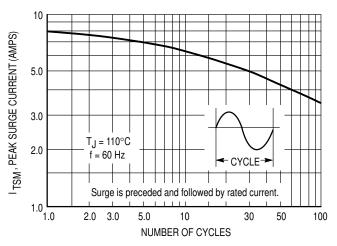


Figure 6. Maximum Allowable Surge Current

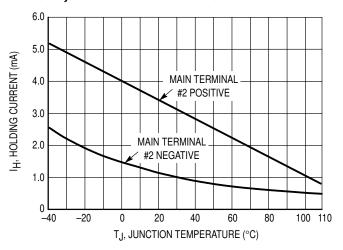


Figure 7. Typical Holding Current Variation

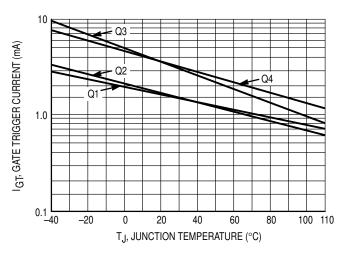


Figure 8. Typical Gate Trigger Current Variation

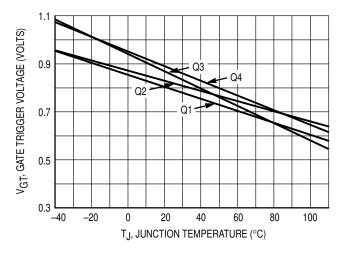


Figure 9. Gate Trigger Voltage Variation

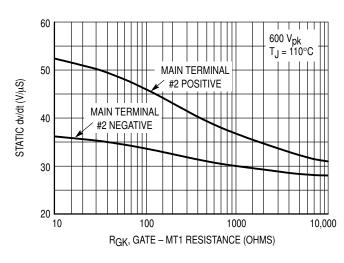


Figure 10. Exponential Static dv/dt versus Gate – MT1 Resistance

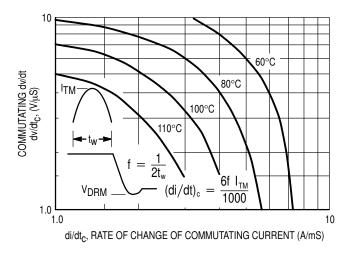


Figure 11. Typical Commutating dv/dt versus Current Crossing Rate and Junction Temperature

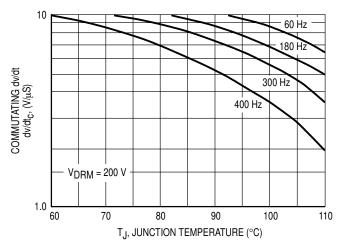
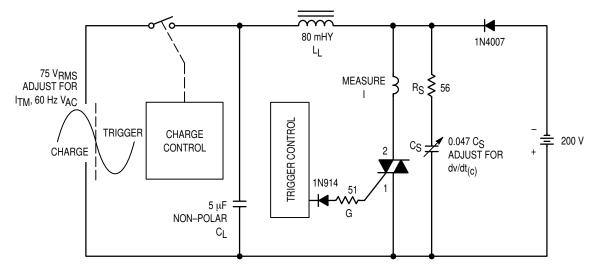


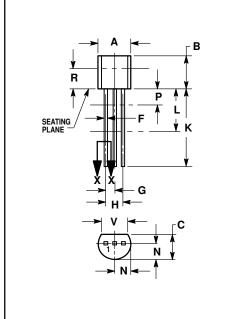
Figure 12. Typical Commutating dv/dt versus Junction Temperature at 0.8 Amps RMS
